# Evaluation of the level of knowledge, Attitude and Misconceptions about Ebola Virus Diseases (EVD) among some University undergraduates in Ondo State, Nigeria

## Abstract

Keywords:	Curtailing a highly virulent infectious disease like Ebola requires good knowledge about the symptoms, transmission and control measures. This study was therefore design to assess the level of knowledge about these parameters among undergraduates of a tertiary
Knowledge,	institution in Ondo State, Nigeria. A well-structured questionnaire was given to each of the
Ebola, Awareness,	492 consenting students from all the six Faculties of Adekunle Ajasin University, Akungba-
Undergraduates, AAUA, Nigeria	Akoko, Nigeria. Data generated were analysed using SPSS package version 21. All respondents (100%) agreed to have heard about Ebola Virus Disease(EVD). Male to female ratio of the respondents was not significant, however, 481 (97.8%) were between age 15 and 30 years. Respondents agreed that EVD can be transmitted through kissing an infected person (87.6%) washing corpse of EVD patient (84.3%) and breast feeding by a symptomatic mother (85.6%). One hundred and forty two (142) respondents believed that EVD can be healed traditionally. Respondents (90.9%) agreed to hand washing as a major control measure. Only 61(12.4%) of respondents know at least one EVD emergency contact number. This study showed that the respondents has good knowledge about EVD. However, the author suggests that hand washing which the respondents agreed to be a good control measure should be resuscitated in all our public places. There should be enlightenment about EVD emergency contact numbers possibly, making it conspicuously displayed in all our public places in Nigeria by the authorities in-charge

### INTRODUCTION

Ebola virus disease (EVD) which is a viral haemorrhagic fever of human and primates was first discovered in West Africa in 1976 (WHO, 2014). It is caused by Ebola virus of the family Filoviridae and has the fruit bat and non-human primates as reservoirs. The transmission of EVD is usually by physical contact with body fluids, urine, breast milk, semen and secretions from infected individuals or corpse of an infected individual especially during funeral rites (Osterholm *et al*, 2015). The virus enters the host primarily through mucosal surfaces or skin abrasion. Ingestion of meats from infected wild animals has been incriminated as sources of infection with the hunters and bush meat processors and sellers at the

highest risk of infection (Vingolo et al., 2015). There are varied clinical disorders which ranges from mild to life threatening situations. Fever, chills, malaise and myalgia occur 8 - 12 days after exposure. These can then be followed by more specific symptoms like terrible diarrhea, nausea, vomiting, abdominal pain, puerperal, bruises, mucosal haemorrhage or oozing of blood from venipuncture sites and unexplained bleeding (Park et al., 2015). In history, there has been many outbreaks of EVD reported mostly in West African countries. The 1976 outbreak was confined to one village and affected 318 people resulting in 280 deaths while in the 2014 outbreak, more than 28,675 people were infected and about 11, 315 people died of Ebola disease. The spread showed

that 4.809 deaths were said to have occurred in Liberia, 3,955 in Sierra Leone, 2,536 in Guinea, 8 in Nigeria, 6 in Mali and 1 in the United States of America (WHO, 2014; Rogo and Auwal, 2018). Air travel was the major course of Ebola virus disease to Nigeria. On July 20th, 2014, an infected airline passenger, a Liberian, arrived Nigeria and caused an outbreak in Lagos and Port Harcourt before the spread was curtailed. In that episode, a total of nineteen (19) people were infected, out of whom eight (8) died on October 20th, 2014 (WHO, 2014). The 2017 outbreak in Congo generated some panic measures against its spread to Nigeria hence no single case was reported. This emphasized the usefulness of preparedness for medical emergencies. It should be noted, that in every preparation, good knowledge of the disease is very crucial. Many studies have been carried out to assess the knowledge of different categories of people about EVD at international level and within Nigeria. Kobayashi et al. (2015) reported a survey covering five (5) counties in Liberia, while others reported on responses among health workers (Joseph et al., 2017; Nchako, 2017) among Tricycle riders (Nwonwu et al., 2017) and among Secondary school students (Ilesanmi and Alele, 2016). The current study was designed to assess the knowledge of Undergraduates of none-medical College about EVD since last episode of 2014, about 5 years ago, to determine our level of preparedness for medical emergencies like EVD.

## MATERIALS AND METHODS

#### Setting:

The study was conducted among undergraduates of Adekunle Ajasin University, Akungba-Akoko, Ondo Nigeria.

### Sample Size

Using n = { $(4*p*(1-p))/L^2$ }, n = { $(4x50/100 \times (1-50/100) / 10/100 \times 50/100$ } = 2x0.5/ 0.05<sup>2</sup> = 1.0/0.0025 =**400** Where; 'p' is assumed to be 50% 'L' precision required = 10% of p Expected range = 40 - 60% the significant sample size was calculated to be **400**, however, **492** respondents were enlisted for this study.

#### Sampling Method

The enlisted students were interviewed with a well structure questionnaire, which were collected back and checked for completeness in both number and attempt at all the questions therein. Student were enlisted from all the six Faculties of the University between October and November, 2017. Participation was made voluntary after explanation of what the study was all about and assurance that responses will be kept confidential and used for the purpose of the study only.

#### **Data Analysis**

Collected data were analyzed using percentages and chi-square test to ascertain the significance of some groups at 5% level of significance with SPSS version 21 package

#### RESULTS

Majority of response in this study falls within the age range of 15-30 (97.8%) and mostly single 428 (87%). These and other socio-demographic characteristics of the respondents are listed in Table 1. Table 2 revealed the responses of participant about their awareness of Ebola disease. All the respondents 492 (100%) agreed to having heard of Ebola Virus Disease while 41 (8.3%) agreed that Nigeria previously had four (4) episode of Ebola Virus Disease. Only 61 (12.4%) agreed knowing an Ebola Virus Disease emergency contact number. Knowledge of respondents about the mode of transmission are captured in Table 3. Kissing a symptomatic person and breast feeding by a symptomatic mother were accepted by 432 (87.6) and 421 (85.6) respectively as means of Ebola Virus Disease transmission. However only 81(16.5%) believed Ebola Virus Disease can be acquired by attending the burial of an Ebola Virus Disease corpse. Ebola Virus Disease is believed to be a curse or spell by 90(18.3%) respondents while 368 (74.8%) believed it is caused by a virus as shown in Table 4. The respondents knowledge about treatments of Ebola Virus Disease showed in Table 5 that 142 (28.9%) and 59 (12.0%) agreed that Ebola Virus Disease can be cured by traditional method and with bathing salt and hot water respectively. Table 6 showed the respondents knowledge about control of Ebola Virus Disease. Regular hand 447(90.9%) washing adequate environmental and personal hygiene 450 (91.5%), wearing of protective gears by care givers 439 (89.2%) and proper disposal of dead bodies of Ebola Virus Disease victims were agreed to by respondents as the major control measures for the spread of Ebola Virus Disease. Respondents attitude are captured in Table 7 where 41 (8.3%) believed that Ebola Virus Disease is not real as against 450 (91.5%) that consented to the fact that Ebola Virus Disease is a serious disease. About 88(17.9%) agreed to keep Ebola Virus Disease sick family member in their houses while 159 (32.3%) deny them of family re-union. Religious leaders 392 (79.7%), 358 Radio (72.8%)and newspapers 337(68.5%) were the main sources of information as responded to by volunteers in this study. This is shown in Table 8. Table 9 shows that there was no significant difference in the responses of male and female respondents to their knowledge of treating Ebola Virus Disease However, the with salt and water. differences across religion, age, marital status were statically significant.

### DISCUSSION

Ebola Virus Disease (EVD) is an infectious disease with high virulence and pathogenicity usually with high mortality. This high mortality rate is further enhanced by lack of effective therapeutic and prophylactic measures. Therefore effective control of this often sporadic disease is for the people to know what to do at a particular time based on good knowledge of the disease. Most of the respondents in this study are between the age range of 15 to 30 years and mostly of the Yoruba tribe. This is expected since they are undergraduates of a university system situated in Yoruba land of Nigeria. It is heart-warming that all the respondents agreed to have heard about Ebola Virus Disease, which means the subject is familiar to them and they can give candid responses. Awareness about Ebola Virus Disease has also been reported to be high among Secondary school students, medical students and communities in the five counties of Liberia. (Ilesanmi and Alele, 2016; Nchako et al., 2017; Kobayashi et al., 2015).

It is however not encouraging that only 12.4% of the respondents know EVD emergency contact numbers, which means the larger population might be helpless should any case be noticed within their environment. Knowledge of respondents about transmission of EVD is very encouraging. Higher percentages agreed that EVD can be transmitted by contact with body fluids of an infected individual. This also agrees with some studies in South-west Nigeria (Mohammed *et al*, 2017;Shittu *et al.*, 2015). Knowledge of modes of transmission will no doubt aid preparedness and prevention of EVD (Basch *et al.*, 2014).EVD been viral borne was known by 74.8% of the respondents. however, it might be a difficult thing for the group that believe EVD is a curse or spell cast on their victims to comply with control or preventive measures, thereby hampering the efforts aimed at curbing its spread.

The concept of bathing with salt and hot water was accepted though by very few respondents. This portends a situation where an EVD patient might result to self-medication of salt and hot water rather than seeking proper and prompt treatment at designated centers.

Respondents' knowledge about control measure gives hope for ability to handle any future epidemics. Regular hand washing was agreed by 90.9% of respondents, a result similar to those reported by other researchers (Rogo and Auwal, 2018; Sarkar *et al.*, 2015). Proper disposal of EVD corpses, isolation of infected individuals or barrier

nursing and wearing of protective gears by care givers are other control measures agreed to by the respondents. Specific antiviral therapy is not available to treat EBV infection. The treatment approach depends on clinical presentations, host immune status and underlying conditions (Zhang *et al.*, 2014).There is equally no licensed vaccine for EVD in humans. However, two experimental vaccines are at various stages of clinical trials and further evaluation in United Kingdom, United States, Switzerland and some African countries (Ledgerwood *et al.*, 2017).

Reasonable number (68.7%) of respondents know how to protect self against EVD, however, 159 (32.3%) respondents do not agree to submitting themselves for treatment should they be infected. This is a very dangerous stance as more family members may be infected and spread thus enhanced. According to the respondents, religious leaders and Radio news are the major sources of information about EVD to people. These assertions agreed with studies of Mohammed et al., (2017) Ilesanmi and Alele (2016) and Shittu et al., (2015). There was no statistical difference between the responses of male and female participants to the treatment of EVD with salt and hot water as indicated in Table 9. However, their responses differed along the lines of other sociodemographic lines like religion, age, marital status and faculty spread. This might be affected by the distribution of respondent which are higher among age group15-30, singles and Christianity religion.

### CONCLUSION

It has been observed that more and regular education through the radio and religious leaders is germane to sustaining our preparedness as a nation for any future EVD epidemic in Nigeria. Emergency EVD phone lines should be conspicuously displayed at all health facilities for people to see and store on their mobile phones. The major control measures agreed to by respondents (hand washing) is speedily disappearing in our public places and this should be re-introduced without further deadly.
