

Analytical Solution of a Mathematical Model for the Dynamics of Diabetes Mellitus and its Complications incorporating Treatment and Positive Lifestyle as Control

Abstract

Diabetes mellitus, complications, treatment, positive lifestyle. In this paper, a mathematical model for the dynamics of diabetes mellitus and its complications incorporating treatment and positive lifestyle as control is developed. The population under study is divided into healthy, susceptible, diabetic without complication, diabetic with complication, diabetic with complications undergoing treatment. The analytical solution of the model is obtained using homotopy pertubation method (HPM). We carry out numerical simulation of the solution and the graphical results are presented. The result of the study established that the disease can be controlled by effective treatment and positive lifestyle.

INTRODUCTION

Diabetes is a disorder in which the body becomes unable to control the amount of sugar in the blood. The pancreas (beta-cells) is not functioning normally, resulting in a partial or total lack of insulin which is the key to the mechanism converting sugar to energy. Consequently, the system is no longer self-regulated and the level of sugar in the blood goes beyond the limits (WHO and IDF, 2004). Diabetes prevalence is rising dramatically worldwide and is expected to rise from 366 million in 2011 to 552 million by 2030 (Wild et al., 2000). More than 10% of world health care expenditure and about 14% of U.S. healthcare costs are attributable to diabetes (WHO, 2014). Diabetes is sweeping the globe as a silent epidemic largely contributing to the growing burden of noncommunicable diseases and mainly encourage by decreasing level of physical activities, poor dieting

and unhealthy lifestyle. It is the sixth leading cause of deaths in the world as reported by WHO. In order to reduce the burden of diabetes and deaths due to complications arising from diabetes, we develop a robust model incorporating treatment and positive lifestyle as measures for controlling the evolution of incidence of diabetes and occurrence of complications of diabetes. Previous research work on diabetes and its complications(IDF, 2014; Adamu et al., 2016; Adewale et al., 2007; Akinsola and Oluyo, 2014; Boutayed et al., 2004; Boutayeb et al., 2006; Padma and Deepa, 2012; Permatasari et al., 2018), were formulated on the belief that the cause of diabetes is genetic disoder. In this work, we consider genetic factors and lifestyle as causes of diabetes and show the effectiveness of the control measures

MATERIALS AND METHODS

The Mathematical Model

The model equations are formulated using first order ordinary differential equations. Improving on the work of Adamu *et al*(2016)

Homotopy Pertubation Method

In recent years, the application of the Homotopy Perturbation Method (HPM) in non-linear problems has been developed by scientists and engineers, because this method continuously deforms the difficult problem under study into a simple problem which is easier to solve. The homotopy perturbation method was proposed first by He in He, (1999) and was developed and improved by He, (2000a), and He, (2004a). Homotopy, is an important part of differential topology. Actually the homotopy perturbation method is a coupling of the traditional perturbation method and the homotopy method in topology He, (2000b). The homotopy perturbation method (HPM) provides an approximate analytical solution in a series form. HPM has been widely used by numerous researchers successfully for different physical systems such as, bifurcation, asymptotology, nonlinear wave equations, oscillators with discontinuities by (He, 2004a), reaction-diffusion equation and heat radiation equation by (Ganji and Rajabi, 2006), Approximate Solution of SIR Infectious Disease Model (Abubakar et al., 2013) and solution of mathematical study of diabetes model (Enagi et al., 2017)

Numerical Simulation and Result

We use mathematical software (MATHEMATICA) to carry out the numerical simulations of H(t), S(t), D(t), C(t) and T(t) and the results are presented in graphical form.



Figure 4.1: Effect of rate at which Susceptible Individual become Healthy on Healthy Class

Figure 4.1 shows that, as the rate at which susceptible individual become healthy increases, the healthy class increases faster. This may be attributable to high positive lifestyle such as good dieting and physical exercises. This shows that the more people adopt positive lifestyle, the less they are susceptible to diabetes

5. Conclusion

We studied mathematical model of diabetes mellitus and its complications incorporating treatment and positive lifestyle as control using Homotopy. Perturbation Method and the result obtained shows that parameters involved played a crucial role in the size of healthy class, susceptible class, diabetics without complications class. diabetics with complications class and diabetics with complications undergoing treatment class at time t.

This research work have established that with adequate control measures such as regular physical activities, good dieting, treatment and reduction in unhealthy lifestyle (smoking, alcoholism and glutoning), prevalence and incidence of diabetes mellitus can be controlled thereby reducing the menace of diabetes and preventing death due to complications of diabetes.
